<p>The diploma thesis is a case report, or cases, of patients that the student has treated during the course of Clinical Practice 1 and Clinical Practice 2. Also, the student may choose a thesis which implies a scientific research work in a laboratory. The student independently decide of the dental field and mentor. In agreement with the mentor a selection of relevant clinical cases or relevant scientific and research laboratory methods is made, the topic of the thesis is defined and specified.</p> <p>The thesis has the following elements: abstract in Macedonian and English, introduction, literature review of the given problem (topic), purpose of the paper, material and method of work, results, discussion, conclusion and used literature. It should be made of not less than 20 and not more than 30 pages, A4 format, font Georgia, font size 11.</p> <p>The student completes his / her thesis in 3 written copies and electronically. It is considered on a teaching board, where a three-member commission is formed upon the proposal of the appropriate Department.</p> <p>A student who has not passed (did not defend his / her thesis) may seek approval of another subject that would be from a different field and implemented under the same procedure.</p>
